Thank you for your interest in becoming a Conservation Corps of Long Beach (CCLB) corpsmember. If accepted, you will gain valuable work experience, as well as the opportunity to work towards your high school diploma or GED.

Being a grant funded, non-profit agency, we must follow guidelines that have been designated by State and Federal laws. One guideline requires that all CCLB participants supply two forms of proper identification on the first day of Orientation. A list of acceptable identification documents is below.
